Financial Updates

The Director of Finance provided the Board with an update on the college's financial position since the last board meeting.

Proposed Amendments to Nurse Practitioner Scope of Practice Standards, Limits, and Conditions: Medical Assistance in Dying (MAiD)

The Board reviewed a recommendation from the Professional Practice and Standards Committee with respect to strengthening the current Nurse Practitioner MAiD standards. The Board discussed how the revised standards would enhance public protection.

WHEREAS the Professional Practice and Standards Committee (the "Committee") has reviewed the proposed amendments to the Scope of Practice for Nurse Practitioners: Medical Assistance in Dying standards, limits and conditions set out in Appendix B of the Board Briefing Note dated April 16, 2024 (the "Briefing Note"), a copy of which has been presented to the BCCNM Board, and the Committee has recommended those revised standards, limits and conditions to the BCCNM Board for approval;

AND WHEREAS the BCCNM Board has considered those proposed amendments to the standards, limits, and conditions and accepts the Committee's recommendation;

RESOLVED THAT the BCCNM Board rescinds all previously established Scope of Practice for Nurse Practitioners: Medical Assistance in Dying standards, limits, and conditions, and in their place approves the revised Scope of Practice for Nurse Practitioners: Medical Assistance in Dying standards, limits and conditions set out in Appendix B of the Briefing Note.

AND FURTHER RESOLVED THAT the revised Scope of Practice for Nurse Practitioners: Medical Assistance in Dying standards, limits, and conditions are in effect 30 days after Board approval.
